The HRS4R Steering Committee (hereinafter referred to as the "Steering Committee") is established to oversee and control the implementation of the HRS4R. The Head of the Steering Committee is also the Head of the SAS Ethics Committee. The Deputy Head of the Committee is the Vice President of the SAS for Science, Research, and Innovation. Other members include the President of the SAS (as an honorary member), the Vice President of the SAS for Budget and Legislation, the Vice President of the SAS for International Relations, and the Vice President of the SAS for individual scientific sections.

The Steering Committee will be regularly informed by the Working Group (see below) about the intention to implement individual steps, the achievement of milestones, and any necessary changes to the HRS4R SAS Action Plan.

In line with their responsibilities in the SAS Presidium, the members of the Committee support the implementation of the project within individual organizations, particularly through expert advice, coordination of activities, and

the sharing of information. The Steering Committee generally meets twice a year, with minutes recorded of its proceedings.

The Working Group HRS4R (the "Working Group") is established to ensure the implementation of the HRS4R. The Working Group discusses the intention to implement specific steps, the achievement of milestones, and the need for changes to the Action Plan. It conducts strategic consultations, approves documents for the SAS Presidium, evaluates proposals for specific measures, and coordinates activities within the framework of implementing the HRS4R strategy.

Working together with HRS4R representatives in individual SAS organizations, the tasks of the Working Group in this context include technical support, coordination of activities, the collection and sharing of information, identifying obstacles with proposed solutions, and monitoring progress.

The Working Group will generally meet four times a year, and twice a year it will meet in an extended format with representatives of the participating SAS organizations.

The meeting shall be convened by the Head of the Steering Committee or by a delegate from the Working Group authorized by the Head.

At least three members of the Working Group from the SAS Presidium and at least two members of the Working Group from the SAS Office shall attend the meeting.

The Steering Committee shall be informed of the outcome through the meeting minutes.
